1. Domaine AGM

You will soon receive details of the domaine AGM for April, 2012 including voting forms. Pam Kilbey has put her name forward for election to the Conseil.

3. Motoring Law

SatNav/GPS

As from January if you are using SatNav/GPS equipment it is illegal if it alerts the driver to locations of either fixed or mobile radar [speed cameras] positions whilst driving. Now in France it must only alert drivers to 'danger zones'.

The fine proposed for being caught with a system that is still alerting the driver to these positions will be \notin 1500 and the offence does carry a very definite 6 point penalty.

I understand that modern equipment from retail outlets and those in car original equipment navigation systems should now conform, althought you may wish to check that it is so. However older equipment will need to have the speed camera location section deactivated/disabled.

I have a Garmin SatNav and by working through the menus it is easy to find this facility and disable it.

Breathalyser Kit

I understand that in the spring of this year it will be necessary for all cars to carry a breathalyser kit. I further understand that there will be an on the spot fine of \notin 15. There are plenty available on line at Amazon and other sites ranging from £3 to over £60.

Mobile Phones

You should also note that if you are stopped for using a hand held mobile phone whilst driving it will attract an on the spot fine of \notin 130 and 3 points.

It is now possible to obtain telepeage equipment in the UK and pay for it and the tolls through your UK Sterling bank account.
